*Themes of the International Conference "Martyr President and the Realization of the New Islamic-Iranian Civilization Based on Quranic Teachings"

Given the objective of examining the scientific, political, and social personality of the Martyr President, the impact of Quranic elements in shaping his character, and his role in guiding the Islamic community toward the establishment of a new Islamic-Iranian civilization, as set by the organizers of the conference, participants wishing to contribute through the production and preparation of scientific papers should consider the following points:

A. Considering the nature of the conference, selected topics should revolve around the personality of the Martyr President, with reference to his scientific and behavioral conduct, as well as his various political and social dimensions.

B. Although researchers have the freedom to choose their topics for paper preparation, in the recognition section, priority will be given to topics determined by the conference's scientific committee.

C. The researcher may prepare the produced paper in a comparative and analytical format.

D. Given the Quranic approach of the conference in the field of research on the thoughts of the Martyr President, priority should be given to incorporating Quranic elements in the selection of the topic and preparation of the paper.

E. The researcher is required to follow the guidelines provided in the conference's website for paper preparation, available at the following address: ...

F. Esteemed authors must submit the abstracts of their papers by January 19, 2025 (30th of Dey, 1403) and the full papers by March 5, 2025 (15th of Esfand, 1403) to the scientific secretariat of the conference at the following address: http://mazandaran.whc.ir

G. The conference includes two special sections with the topics "Cultural Governance in the Political Conduct of Martyr Raisi" and "... Public Diplomacy in the Social Conduct of Martyr President," where interested individuals can submit their works in the form of photographs, ...

Guidelines for Paper Preparation in the International Conference "Martyr President and the Realization of the New Islamic Civilization Based on Quranic Teachings"

Initial Conditions for Paper Acceptance

- **). Relevance to the Conference Theme**
 - The paper must be directly related to the theme of the International Conference "Martyr President and the Realization of the New Islamic Civilization Based on Quranic Teachings."

۲. Editorial Review

• The conference secretariat, based on the opinions of the scientific committee, holds the authority to accept, reject, or edit papers for scientific and literary quality.

۳. Originality of the Paper

• Papers submitted to the conference must not have been previously presented or published elsewhere, nor should they be simultaneously submitted for publication in other journals or conferences.

2. Format for Paper Submission

- The paper must be submitted in **Word format (DOCX)**, using **Noorzar Nazok 13 pt** for Persian text, or **B Nazanin** for Persian and **Times New Roman** 10 pt for English text.
 - A **PDF file** is not acceptable for review.

°. Conditions for Papers Extracted from Other Works

- If the paper is derived from any of the following sources, the author must provide complete information about the original work. If this is not done, the conference secretariat will take appropriate action:
 - Thesis (complete title, supervisor's name, defense date, university, faculty, and academic department)
- **Papers submitted by students (Master's or PhD)** are not acceptable without the name of the supervising professor.

7. Submission Process

- Authors must submit their papers exclusively through the paper submission section of the conference system. (The submission link will be provided later.)
- The corresponding author must first register in the conference system's "Submit Paper" section to upload the paper.

V. Tracking the Review Process

- Authors must track all stages of the paper review process solely through their personal page on the conference system.
- **^. Template and Topics for Accepted Papers**

• Papers must adhere to the conference's **template** and be aligned with the **approved topics** as listed by the organizing committee.

By adhering to these guidelines, authors ensure the smooth acceptance and evaluation of their papers for the conference.

Additional Conditions for Paper Submission

1. Research-Based Papers Only

• The conference secretariat will only accept papers that are based on the author's own research and present new findings or contributions to the field.

Y. Exclusion of Certain Paper Types

• The secretariat will not accept purely review papers, compilations, reports, or translations.

۳. Paper Length

- Total Word Count: Between 5000 and 6000 words
- **Keywords**: 4 to 8 keywords should be chosen from the main, sub, and related topics of the paper.
- **Abstract**: Between **150 to 200 words**. The abstract must include the purpose, main research question, methodology, and key findings of the research.

i. Author Information

- The corresponding author for multi-author papers must be clearly indicated. The phrase "**Corresponding Author**" should be placed next to the name of the corresponding author.
- The person submitting the paper is considered the corresponding author and all subsequent correspondence will be directed to them.

°. Affiliations of Authors

- Authors' organizational affiliations must be precise and follow one of the formats below:
 - **Faculty Members:** Academic rank (Assistant Professor, Associate Professor, Professor), department, university, city, country, institutional email address.
 - ^Y. **Students**: Degree level (Bachelor's, Master's, PhD), field of study, university, city, country, institutional email address.
 - ^r. Independent Researchers: Degree level (Bachelor's, Master's, PhD), field of study, institution, city, country, institutional email address.
 - Seminary Students: Level (4, 3, 2), field of study, seminary, city, country, email address.

٦. Paper

Structure

The main body of the paper should include the following sections in order:

- **1. Title**: The title must be concise, clear, and reflective of the paper's content, preferably as brief as possible.
- ^Y. **Abstract (in Persian)**: The abstract should include the following:
 - Topic/issue/question being addressed
 - Objective of the research
 - Methodology
 - Key findings or results

Structure of the Paper

۱. Introduction

The introduction should include the following elements:

- **Problem Definition**: Clearly state the issue or research question.
- Literature Review: Review the previous research on the topic, providing both Persian and English sources.
- **Significance and Necessity of the Research**: Explain the importance of the study and the reason it is essential to pursue this topic.
- **Novelty of the Paper**: Justify why the topic of the paper is new or unique in the field.

۲. Main Body

• This section should provide detailed explanations, discussions, and analyses of the topics related to the research question. It should logically organize the arguments and data presented.

۳. Conclusion

- In **10 to 15 lines**, summarize the key points of the paper and explain the conclusions derived from the study.
- The conclusion can discuss the implications of the research, suggest further areas for exploration, or propose how the findings might be applied in related fields.

٤. References

- The reference list should include all sources cited in the paper, arranged alphabetically, with **Persian** sources listed first, followed by **English** sources.
- Sources must follow the **APA** referencing style, including in-text citations, footnotes, and the reference list.

Citation Format

). For Persian Sources:

 In-text citation: (Author's Last Name, Year of Publication: Page Number)

- If citing a hadith or chapter in a book: (..., B4, H9)
- For journal articles, cite similarly to books, but start with the author's last name, followed by the publication year and page number.

۲. For Quranic Verses:

• Cite only the surah and verse number in this format: (Anbiya: 105)

^ψ. For English Sources:

 In-text citation: (Page Number: Year of Publication, Author's Last Name)

Example: (Gordon, 1998: 23)

• If an author has multiple works published in the same year, distinguish them by letters after the year (e.g., Gordon, 1998a; Gordon, 1998b).

٤. Footnotes:

- Necessary explanations and English equivalents should be included in footnotes, numbered sequentially throughout the paper.
- °. Formatting of References at the End:
 - **Order**: First list **Persian** references, followed by **English** references.
 - Ensure all cited references are included in the reference list and match the citations used in the text.

This structure ensures clarity, proper referencing, and organization, which will help in the acceptance and evaluation of the paper for the conference.
